Executive Summary

March 31, 2015 marks the end of the second annual reporting period in the GO Bond program's implementation, approximately 28 months following overwhelming approval by the voters of the Bond referendum in November of 2012. Over the course of the year, the District successfully completed a number of milestones and initiatives on several fronts, as evidenced below. In all, the District had almost 240 projects on deck at different stages ranging from substantially completed to planning and predesign.

Students throughout Miami-Dade County are already benefitting from the investment made in GO Bond projects at their schools. Classrooms are being transformed into 21st Century instructional spaces with new technology, windows, air conditioning, lighting and other improvements. New playgrounds, parent drop-off areas and other site upgrades are in use at schools throughout the District.

As summer approaches, construction activities will intensify at many schools. The following provides an overview regarding the status of GO Bond projects.

Year 1 Projects:

Out of 66 projects under \$2M in value:

- 4 23 were completed;
- 🖶 39 were in construction; and
- + The balance was in bidding or plan review.
- ✓ The 2 other projects, replacement of Miami Norland Senior High and a new grade 6-12 addition @ M.A.S.T. on Virginia Key, were in construction with the former in track to open in 2016 and the latter in August of 2015.

Accelerated Projects:

- ✓ Out of 137 projects district-wide:
 - 80 were completed;



Year 3 (54 Projects Plus Accelerated Scope)




Balance in design



S/MBE AND M/WBE PROGRAMS

- Final Reading of Board Policies 6320.02, Small/Micro and Minority/Women-Owned Business Enterprise Programs and 6320.05, Local Vendor Preference-Scheduled for October 14, 2015 Board meeting
 - Policy 6320.02 SMBE/MWBE
 - Accepts findings of Euquant, Inc., that there is a disparity in the Board's utilization of African-American construction subcontractors and adds this category to those for which the Board previously authorized narrowly tailored combination of race and gender-neutral and race and gender- conscious measures to address discrimination.
 - Adds and clarifies OEO responsibilities to (1) include implementation of measures developed under the Board's new policy 6320.06, *Diversity, Equity and Inclusion in Business Operations and Practices,* which is designed to increase diversity, equity and inclusion in business practices and operations, and (2) enforce compliance with all aspects of these policies.





S/MBE AND M/WBE PROGRAMS

Policy 6320.02 – SMBE/MWBE (Cont'd.)

- Authorizes the Superintendent to develop affirmative initiatives and incentive programs to increase utilization of diverse SMBE and M/WBE subcontractors pursuant to the new Policy 6320.06
- Adds provisions that require certification applicants to provide truthful and accurate information or be subject to criminal charges and other consequences provided by the policy such as contract termination, debarment, etc.
- Revises upward the average gross threshold limits for graduation from the SBE program.
- Adds additional due process and clarifies appeal provisions for SMBEs and M/WBEs if they are denied certification or are suspended from the program.
- Separates out the Service Disabled Veteran Enterprise Program as a distinct program and removes it from the M/WBE program since it is race and gender neutral.



S/MBE AND M/WBE PROGRAMS

Policy 6320.02 – SMBE/MWBE (Cont'd.)

- Clarifies that M/WBE applicants may self-identify as a minority person under the policy definitions; OEO is authorized to ask for additional documentation if there is a suspicion of fraud.
- Expands the geographic area for certification eligibility from Miami-Dade County only to also include Broward and Palm Beach.
- Includes the new statutory prohibitions on application of local preference to procurement of construction services.
- Adds language encouraging fair subcontracting.
- Requires prompt payment to contractors and subcontractors.
- Changes OEO reporting requirements from quarterly to annual.



LOCAL PREFERENCE

Policy 6320.05, Local Preference

- Broadens the policy from application of Board's local vendor preference only to include state laws requiring vendor and employment preferences for Florida businesses and residents; changes name to Vendor and Employment Preferences.
- Adds new statutory prohibitions on use of local preference requiring that for construction projects funded 50% or more through state appropriations, local preference cannot be awarded; clarifies that this does not apply to locally funded construction projects.
- Clarifies that for services that are subject to the Consultants' Competitive Negotiation Act (CCNA), when a local firm that is not initially short-listed for interviews and has a score within 5% of the lowest-ranked short-listed firm's score, it will be added to the short-list if the lowest ranked short-listed firm is non-local.
